The Meeting started with opening address from the Chair.

The Director, IQAC presented a brief report on the various activities undertaken since September 2023.

The following matters were resolved.

- 1. The minutes of the IQAC meeting held on 29.9.2023 and action taken report was discussed and approved.
- The advisory of NAAC on Green audit as per ISO50001 was presented and discussed. It was
 agreed that the Green and Energy Audit will be initiated by inviting all eligible organizations
 through an open tender process. The possibility of involving TERI and any other government
 organization will also be explored.
- 3. The new procedure for review of Journal proposals by faculty members for submission to the UGC CARE will be implemented with immediate effect.

- 4. A proposal to introduce an additional option for online verification of certificates was discussed. VFS made a presentation on their portfolio. Members felt this may facilitate students sharing verified certificates to various organizations. The Controller of the Examinations in consultation with VFS will take further action in this regard.
- 5. The completion of the Academic Audit by various academic units was reviewed, the Vice Chancellor stressed the need for completion of the Academic Audit by all units.
- 6. The status of the NEP road map by various academic units was discussed. School Board reports and resolutions on the NEP are expected to be presented to the Academic Council.
- 7. Under any other item, it was proposed to introduce, one page in the PhD thesis on how the PhD thesis addressed SDG goals. A model page is included. The Controller of Examinations suggested that this page could be included in the Samarth portal along with other requirements for the PhD which is in the process of finalization.
